4.2 Most important symptoms and effects, both acute and delayed

Symptoms : Oil acne/folliculitis signs and symptoms may include formation

of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.

Local necrosis is evidenced by delayed onset of pain and

tissue damage a few hours following injection.

seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.
